Training Equipment Requirements

Trainer to:

- Ensure a risk analysis/assessment is available for the practical assessment
- Ensure (when using coatings, solvents etc) that the products have been assessed and control measures are in place (COSHH or equivalent)
- Ensure the student has the required PPE and RPE. If you cannot provide these, inform them before the course.
- Ensure the plant and equipment are safe to use and (where applicable) tested/certified for use
- Ensure the test plates are suitable as per the practical assessment guides (or the alternative live structure, if this meets the requirements)



Blast chamber that will allow the student and trainer access (3m x 6m minimum)	
Spraying Facilities (specialist spray painting module)	
The spraying should be conducted in an environment suitable for coating application in a safe manner that allows access to the student and trainer. This could be a spray booth (3m x 3m minimum) or a paint shop with suitable flooring, lighting and extraction	





Theoretical	
Classroom must be a suitable size to accommodate the number of trainees attending the course	
A laptop/PC to access the training material



Online Course Delivery Model

- 1. The Trainer registers students to the TTP website.
- The Trainer selects the course for the student and decide if studying online or in the classroom.
- 3. Online students will get an automated email with details of how to log on.
- 4. The student logs on to complete all training, end-of-unit assessments and final theory exams. Access to the platform is available for 12 months.
- 5. The Trainer will be notified by email once the student has completed the online training and assessments.
